

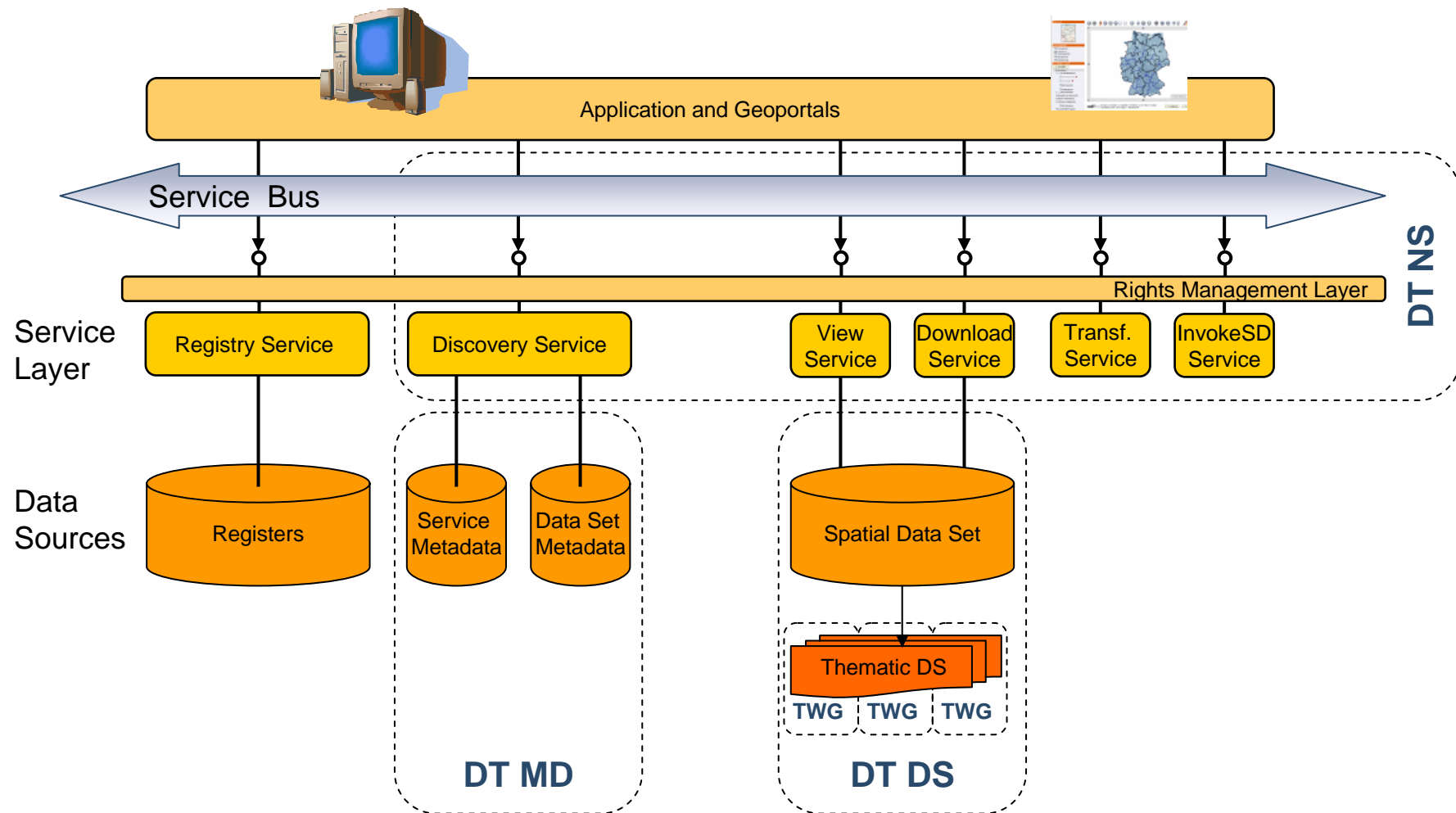

- *”Metadata, geodatasæt og geodatatjenester, net tjenester og netteknologier, **aftaler om adgang og anvendelse og om gensidigt at stille geodatasæt og geodatatjenester rådighed** samt koordinerings- og overvågnings-mekanismer, processer og procedurer, der opbygges, drives eller stilles til rådighed i medfør af denne lov.”*
